



Q2 [Required] If you live in the County, in which area do you live?


Q3 [Required] How long have you been a resident of Elbert County?


Q13 [Required] Are new, additional residential developments needed in Elbert County?

Q14 What types of new, additional residential developments are needed in Elbert County? (select all that apply)




Q15 What economic development focus areas do you believe would be most beneficial for improving the economic well-being of Elbert County?

Q20 When considering Elbert County's existing transportation network, identify if each of the following is currently a strength or weakness.








Q22 If you are employed, how far do you generally commute?







